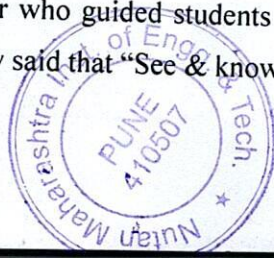
Brief about Event: The expert session aimed to delve into the latest advancements, challenges, and applications of field of Automation.
